THE HUNGARIAN CLUB AGREES TO RENT OUT ITS FACILITIES UNDER THE FOLLOWING CONDOTIONS:

THE HALLS ARE AVAILABLE FROM 12:00 PM UNTIL 12:30 AM. MUSIC MUST STOP AT 12:30 AM WITH CLEAN-UP OF THE HALLS TO END NO LATER THAN 1:30 AM. THA HALLS ARE TURNED OVER TO THE RENTERS IN A SIMILAR STATE. THE PARCING LOT AND SURROUNDIG AREA OF THE CLUB WILL BE INCLUDED IN THE CLEAN-UP PROCEDURE. A PORTION OF THE SECURITY DEPOSIT MAY BE FOREITED IF THE VACANTING OF THE HALL GOES WELL BEYOND THAT TIME.

ALCOHOLIC BEVERAGES MUST NOT BE SERVED TO ANY PATRON OR GUEST UNDER THE AGE OF 21! CONSUMPTION OF ALCOHOLIC BEVERAGES IN THE PARCING LOT OR SURROUNDING AREAS OF THE CLUB ARE PROHIBITED BY THE TOWN OF WALLINGFORD, AS WELL AS THE CLUB.

NOISE ORDINANCES IN EFFECT IN WALLINGFORD MUST BE ADHERED TO, EXCESSIVELY LOUD BANDS OR D.J.S MAY RESULT IN THE POLICE BEING CALLED BY THE SURROUNDING HOMES. THE CLUB ASSUMES NO RESPONSIBILITY FOR THE PAYMENT OH ANY FINES ASSESSED WHILE AN EVENT IS ONGOING. THE DOORS SHOULD REMAIN CLOSED WHILE THE BANDS ARE PLAYING.

CONFETTI AND BUBBLE GUM ARE HARD TO REMOVE AND THEREFORE ARE PROHIBITED. ALSO PROHIBIOTED ARE ANY FIREWORKS, SMOKE MACHINES, DRY ICE, OR ANY PYROTECNICS THAT WIL SET OFF THE FIRE ALARMS.

SETTING UP AND THE KNOCKING DOWN OF CHAIRS AND TABLES ARE THE RESPONSIBILITY OF THE RENTERS. BOTH HALLS HAVE COMPLETE KITCHEN FACILITIES AND ARE INCLUDED IN THE RENTAL FEE. A FIRE SUPPRESSION SYSTEM HAS BEEN INSTALLED IN THE UPPER HALL. ACCIDENTAL SETTING OFF OF THIS SYSTEM WILL RESULT IN A CHARGE OF 1,000, OR THE AXACT COST TO THE CLUB FOR RE-CHARGING THE SYSTEM.

THE CLUB ASSUMES NO RESPONSIBILITY FOR DAMAGES DONEE TO PERSONAL PROPERTY IN AND SURROUNDING THE CLUB WHILE AN EVENT IS IN PROGRESS, NOR ANY RESPONSIBILITY FOR LOST OR STOLEN ITEMS.

FEES AND CHARGES:

A SECURITY DEPOSIT OF NO LESS THAN \$300.00 NOR GREATER THAN \$1,000.00 WILL BE REQUIRED TO HOLD A DATE, AND TO PROTECT THE CLUB AGAINST DAMAGES BY RENTERS OR THEIR QUEST. THE AMOUNT IS TO BE DETERMINED BY THE RENTAL AGENT, DEPENDING ON THE TYPE OF EVENT AND PAST HISTORY WITH THE RENTERS.

CANCELLATION OF AN EVENT LESS THAN 30 DAYS PRIOR TO THE EVENT, RESULTING IN OUR INABILITY TO RE-RENT THE FACILITY WILL RESULT IN THE FORFEITURE OF THE SECURITY DEPOSIT. POLICE INVOLVEMENT IN ANY EVENT WILL ALSO RESULT IN A LOSS OF THE DEPOSIT. IF NO DAMAGE OCCURS AND NO OTHER OBSTACLES ARISE, THE DEPOSIT WILL BE RETURNED WITHIN 1 WEEK OF THE EVENT.
